GEC'S CURRENT PRIMARY PARTNERSHIP IS WITH THE IMMACULATE HEART SISTERS OF AFRICA, SUPPORTING THEIR INITIATIVE TO DEVELOP AND GROW THE KITENGA SECONDARY SCHOOL FOR GIRLS IN TANZANIA. THE SCHOOL OPENED IN 2017 AND IS GROWING EVERY YEAR UNTIL FULL BUILD-OUT FOR APPROXIMATELY 480 STUDENTS.
